The Government of the Republic of North Macedonia has received financing from the World Bank toward the cost of the Social Services Improvement Project (SSIP), and intends to apply part of the proceeds toward payments under the contract for Development and Implementation of an Integrated Social Welfare Information System covering both Social Assistance Benefits and Services in the Republic of North Macedonia.

The Ministry of Labour and Social Policy of the Republic of North Macedonia now invites sealed Bids from prequalified eligible Bidders for Development and Implementation of an Integrated Social Welfare Information System Covering both Social Assistance Benefits and Services in the Republic of North Macedonia.

Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers-Procurement in Investment Projects Financing" issued in July 2016 and revised November 2017 ("Procurement Regulations"), and is open to all prequalified eligible Bidders.

designated representatives and anyone who chooses to attend at the address below (at the end of this RFB) **on 11:00 hours Macedonia Time (GMT + 1), on April 5, 2022.**

7. All Bids must be accompanied by a Bid Security of MKD 600.000,00 or an equivalent amount in a freely convertible currency.

8. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
